**AN ORDINANCE ANNEXING CERTAIN TERRITORY INTO THE

Pinson; and

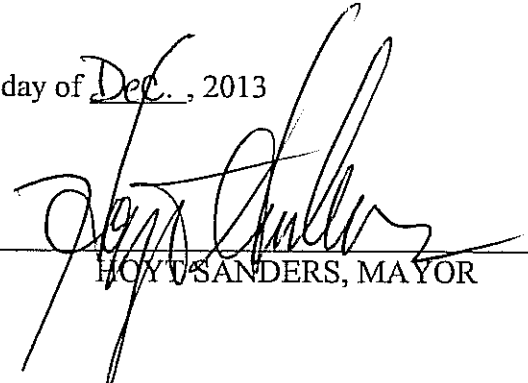
WHEREAS, the Property is not within the corporate limits or the police
jurisdiction of any other municipality,

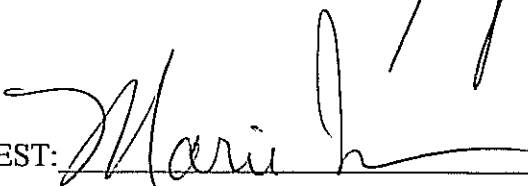
NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of

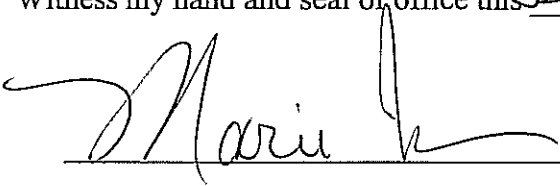

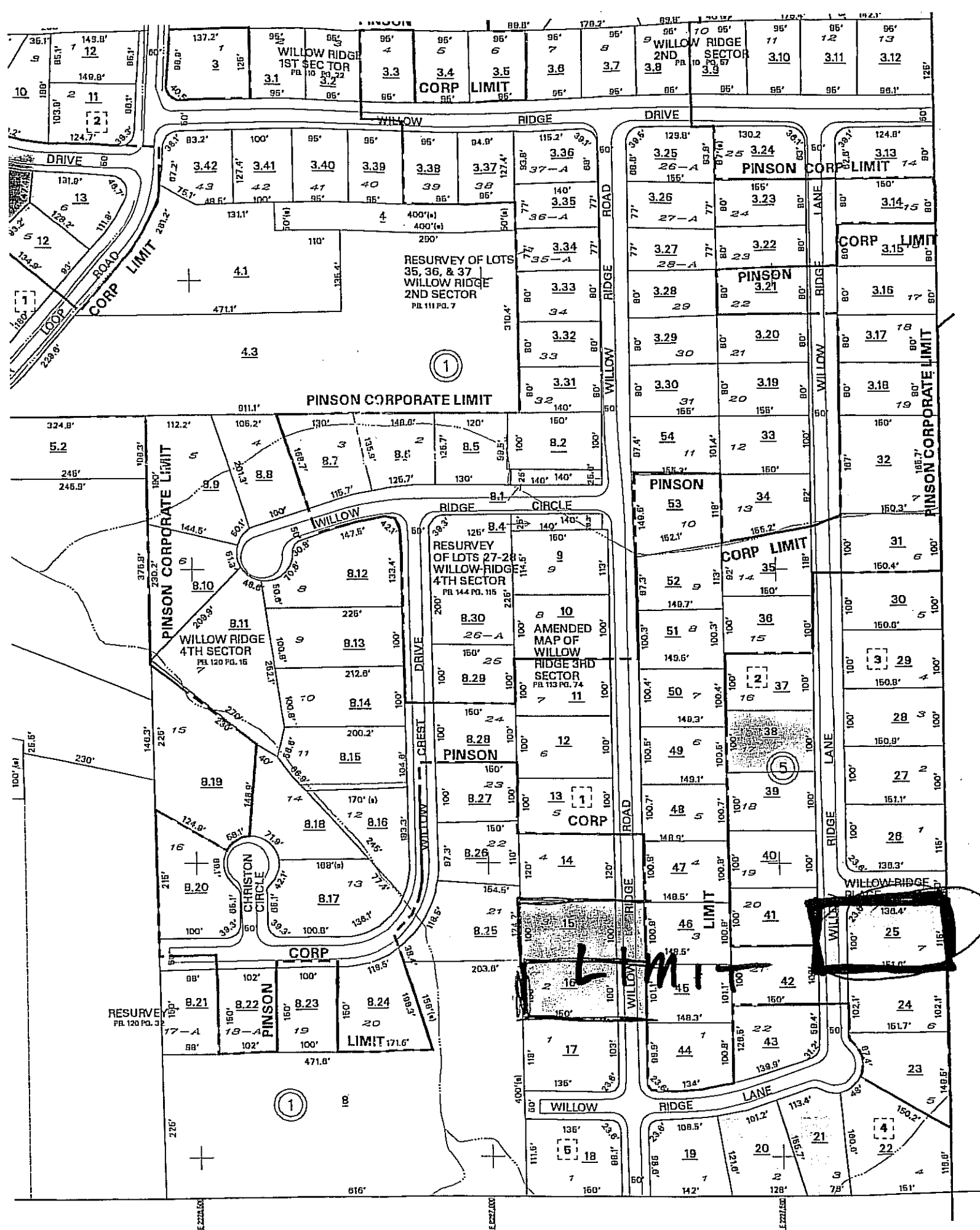
