AN ORDINANCE CHANGING THE ZONING CLASSIFICATION OF REAL ESTATE LOCATED IN THE CITY OF PINSON, ALABAMA

WHEREAS, **John & Cresence NAIL** <u>and</u> **William GOGGANS** <u>and</u> **PERRY JEFFERY & DEBORAH DIANNA BACHELOR** ("Owner") are the respective owner(s) of the following described parcels of land located in the City of Pinson ("Real Estate"):
