NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Pinson, Alabama as follows:

1. The zoning classification of the Real Estate is hereby changed from Parcel 9-9-3-2-4.000, Jefferson County A1 to City of Pinson **RR (Rural Residential)**; Parcel 9-29-2-0-9.000 & 11.000, Jefferson County CP to City of Pinson CI (Community Institutional); Parcel 9-29-2-0-9-15.001, Jefferson County A1 to City of Pinson CI (Community Institutional).
