# AN ORDINANCE CHANGING THE ZONING CLASSIFICATION OF REAL ESTATE LOCATED IN THE CITY OF PINSON, ALABAMA

recommended to the City Council that the zoning classification of the Real Estate be changed to City of Pinson RR (Rural Residential)

WHEREAS, after considering the recommendation of the Planning Commission and all pertinent matters presented at a public hearing held by the City Council on November 6, 2014 to consider the Owner's request that the zoning classification of the Real Estate be changed from Jefferson County A-1; R-2; R-4 & R-5B to City of Pinson RR (Rural Residential), the City Council determined that the zoning classification of the Real Estate should be changed from Jefferson County I-1; R-1 & C-1 to City of Pinson RR (Rural Residential)

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Pinson, Alabama as follows:

1. The zoning classification of the Real Estate is hereby changed from Jefferson County A-1; R-2; R-4 & R-5B to City of Pinson RR (Rural Residential).

2. This ordinance shall become effective upon its adoption and publication as required by law.
