WHEREAS, after a public hearing held on October 28, 2014 to consider a recommendation to be made to the City Council of the City of Pinson with respect to the requested rezoning of the Real Estate, the Planning Commission of the City of Pinson recommended to the City Council that the zoning classification of the Real Estate be changed to City of Pinson RR (Rural Residential) parcel 13-2-1-6-1.007;13-2-1-5-4.005; &13-2-1-5-5.000; and AG (Agriculture) parcels 13-2-1-5-4.004; & 13-2-1-1-3.002; and CU(Current Use) parcel 13-2-1-6-1.007

WHEREAS, after considering the recommendation of the Planning Commission and all pertinent matters presented at a public hearing held by the City Council on November 6, 2014 to consider the Owner's request that the zoning classification of the Real Estate be changed from Jefferson County A-1 & R-1 to City of Pinson RR (Rural 13-2-1-6-1.007;13-2-1-5-4.005; parcel &13-2-1-5-5.000: Residential) (Agriculture) parcels 13-2-1-5-4.004; & 13-2-1-1-3.002; and CU(Current Use) parcel 13-2-1-6-1.007, the City Council determined that the zoning classification of the Real Estate should be changed from Jefferson County A-1 & R-1 to City of Pinson RR (Rural Residential) parcel 13-2-1-6-1.007:13-2-1-5-4.005: &13-2-1-5-5.000: (Agriculture) parcels 13-2-1-5-4.004; & 13-2-1-1-3.002; and CU(Current Use) parcel 13-2-1-6-1.007.
