NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Pinson, Alabama as follows:

1. The zoning classification of the Real Estate is hereby changed from Jefferson County A-1 & R-1 to City of Pinson RR (Rural Residential) parcels 2.001 and 5.000 and RL (Residential Low Density) parcel 8.000; 10.000, & 2.000
