

RESOLUTION NO. 15-42

**A RESOLUTION CONCERNING CONDITIONS AT
FOUR PROPERTIES – 5896 RED HOLLOW ROAD, 6809 RIDGEWOOD DRIVE,
AND 6905 BRITTANY LANE, AND DIRECTING ACTION WITH RESPECT TO
THEM**

WHEREAS, the City Council finds that the real property located at 5896 Red Hollow Road, in the City's police jurisdiction, is in an unhealthy, unsanitary, and/or unsafe condition, attributable to a number of junked, inoperable, and/or demolished vehicles located thereon;

WHEREAS, the City Council finds that the real property located at 6809 Ridgewood Drive, in the City's police jurisdiction, is in an unhealthy, unsanitary, and/or unsafe condition, attributable to an abundance of overgrown weeds and vegetation located thereon;

WHEREAS, the City Council finds that the real property located at 6905 Brittany Lane, located within the city limits, is in an unhealthy, unsanitary, and/or unsafe condition, attributable to an abundance of debris, garbage, and refuse located thereon; and

**THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE
CITY OF PINSON, ALABAMA** while in regular session on Aug 6, 2015 at 7:00
p.m. as follows:

1. The City Council finds that the above-described conditions at (i) 5896 Red Hollow Road, (ii) 6809 Ridgewood Drive, and (iii) 6905 Brittany Lane, constitute public nuisances which threaten the public health, safety, and welfare, and that the same must be


abated. The Mayor and City Attorney are authorized to initiate civil litigation in the Circuit Court of Jefferson County, Alabama against the owner(s) and/or responsible parties with respect to the above conditions at (i) 5896 Red Hollow Road, (ii) 6809 Ridgewood Drive, and (iii) 6905 Brittany Lane, and to cause the abatement of such public nuisances, and (where possible) to recover costs and expenses associated therewith.


