ORDINANCE NUMBER 2023 - 01

AN ORDINANCE OF THE CITY OF PINSON, ALABAMA, TO EXEMPT CERTAIN "COVERED ITEMS" FROM THE MUNICIPAL SALES AND USE TAX ON THE THIRD WEEKEND OF JULY 2023, AS AUTHORIZED BY § 40-23-213 OF THE CODE OF ALABAMA, GENERALLY REFERRED TO AS THE STATE SALES TAX HOLIDAY LEGISLATION AND CERTAIN EMERGENCY PREPAREDNESS ITEMS UNDER ACT NUMBER 2-12-256, FEBRUARY 24-26, 2023.

BE IT ORDAINED BY THE CITY COUNCIL OF PINSON, ALABAMA, AS FOLLOWS:

Section 1. In conformity with the provisions of § 40-23-210, et seq. of the Code of Alabama, providing for a State Sales Tax Holiday, the City of Pinson, Alabama, exempts "covered items" from municipal sales and use tax during the same period, beginning at 12:01 a.m. on the third Friday in July 2023 (July 21, 2023) and ending at twelve midnight the following Sunday (July 23, 2023).

Section 2. This ordinance shall be subject to all terms, conditions, definitions, time periods, and rules as provided by § 40-23-210, *et seq.* of the *Code of Alabama*, providing for a State Sales Tax Holiday, except that the time period shall only be as specified in Section 1 above and not for all years thereafter.

Section 3. The City Clerk is hereby authorized and directed to certify a copy of this ordinance under the seal of the City of Pinson, Alabama, and to forward said certified copy to the Alabama Department of Revenue to be recorded and posted on the Department website.

Section 4. In addition to the items covered above, The City of Pinson also exempts certain emergency preparedness items, along with the State of Alabama in accordance with Act 2012-256 beginning at 12:01am Friday, February 24, 2023 and ending at midnight on Sunday, February 26, 2023.

Section 5. This ordinance shall become effective immediately upon its publication.
