ORDINANCE NO. 2020-15

AN ORDINANCE AUTHORIZING THE CITY'S EXCHANGE OF CERTAIN REAL PROPERTY LOCATED AT 3104 AND 3108 SWEENEY HOLLOW CIRCLE FOR PROPERTY LOCATED IN THE TURKEY CREEK NATURE PRESERVE

WHEREAS, § 11-40-1 of the *Code of Alabama* authorizes the City of Pinson to enter into contracts and to acquire real property;

WHEREAS, § 11-47-20 and § 11-43-56 of the *Code of Alabama* authorize the City Council to dispose of real property;

WHEREAS, the City Council desires to exchange certain property (referred to herein as the "City's Property") acquired by the City last year from the Heirs of Clifford J. Balzli, Sr., in exchange for certain property (referred to herein as the "Turkey Creek Property") located in the Turkey Creek Nature Preserve, all as described in the memorandum of agreement attached hereto as **Exhibit A** (referred to herein as the "MOA");

WHEREAS City Council finds that the City's Property is surplus and is not needed for municipal and public purposes;

WHEREAS, the City Council finds that the City of Pinson's acquisition of the Turkey Creek Property serves a valuable public purpose.

THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PINSON, ALABAMA while in regular session on August 6, 2020 at 7:00 p.m., as follows:

- 1. The Mayor, on behalf of the City of Pinson, Alabama, is directed to exchange the City's Property in exchange for the Turkey Creek Property. The Mayor is further authorized to enter into the MOA, for and on behalf of the City, for this purpose.
- 2. The Mayor is further authorized to carry out the terms of the MOA as soon as may be practicable, and to execute such other and additional documents that may be necessary and/or required in order to facilitate the transaction described herein.
