# A RESOLUTION ASCERTAINING, FIXING AND DETERMINING THE AMOUNT OF ASSESSMENT TO BE CHARGED AS A RESULT OF THE CITY ORDERING THE ABATEMENT OF LITTER/JUNK ON PROPERTY LOCATED IN THE CITY OF PINSON, ALABAMA PURSUANT TO ORDINANCE NO. 2020-14

**WHEREAS**, the appropriate municipal official has made a report to the Council of said costs, including the cost of complying with Ordinance No. 2020-14, the sum of which was \$9,447.50; and

WHEREAS, the City Clerk set the report of costs for a public hearing at a meeting of the Council on December 2, 2021 at 7:00 p.m. and gave no less than ten (10) days notice of the public hearing by certified mail to all persons or entities listed in Ordinance No. 2020-14; and

WHEREAS, said public hearing was held by the Council; and

WHEREAS, it is now the desire of the Council to fix the costs which it finds were reasonably incurred in connection with the abatement of said litter/junk nuisances and assess the costs.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of Pinson, Alabama while in regular session on December 2, 2021 at 7:00 p.m. as follows:

<u>Section 1.</u> That the Council hereby assesses the sum of \$9,447.50 to be the costs reasonably incurred by the City in connection with the abatement of said litter/junk nuisances located on the previously described property.

Section 2. That the City Clerk be authorized and directed to file a certified copy of this resolution in the office of the Judge of Probate of Jefferson County, Alabama. That the City Clerk be authorized and directed to issue a final assessment in the amount of \$9,447.50 to the interested persons above as provided by law and that, in the event of a failure to pay the assessment when due, the City Attorney is hereby authorized to take any and all actions necessary to prosecute the lien as permitted by law.
